Background:

On November 14, 2006, the Board awarded a contract to A. Bates General Contractor in the amount of \$394,950.00 for the subject project.

Issue:

Pursuant to Civil Code Section 3093, a Notice of Completion must be filed within 10 days after the completion of the work or improvement. The design architects, engineers, inspectors, and construction/project managers have inspected the project and are satisfied that all work has been completed per the contract documents.

To ensure the district has received all preliminary 20-day and stop notices per Civil Code Sections 3183 – 3184, retention will be held for not less than thirty-five (35) days. In accordance with Public Contract Code Section 7107, retention will be held not more that sixty (60) days.

Fiscal Impact:

The completed construction contract amount is \$457,170.16.

Funding Source:

This project was funded with Measure I-98 bond funds (Fund 24)

Recommendation:

It is recommended that the Board accept the completed contract and direct staff to file the Notice of Completion with the County Records Office.
