Background:

On May 8, 2007, the Board awarded a contract to Brannon Inc., DBA Smith Electric in the amount of \$398,000.00 for the subject project.

Issue:

Pursuant to Civil Code Section 3093, a Notice of Completion must be filed within 10 days after the completion of the work or improvement. The design architects, engineers, inspectors, and construction/project managers have inspected the project and are satisfied that all work has been completed per the contract documents.

To ensure the district has received all preliminary 20-day and stop notices per Civil Code Sections 3183 – 3184, retention will be held for not less than thirty-five (35) days. In accordance with Public Contract Code Section 7107, retention will be held not more that sixty (60) days.

Fiscal Impact:

The completed construction contract amount is \$418,993.00.

Funding Source:

This project Base Bid and Alternate #3 were funded with Measure V bond funds (Fund 21), Alternate #1 (seat replacement) was funded by the Foundation, and Alternate #2 (floor refinishing) was funded by the Santa Barbara High School Discretionary Block Grant (Fund 01).

Recommendation:

It is recommended that the Board accept the completed contract and direct staff to file the Notice of Completion with the County Recorders Office.
