Background:

On November 4, 2008, the voters of Santa Barbara County supported the Santa Barbara School Districts by passing special parcel taxes to benefit the high school and elementary districts, Measure H and Measure I. The funds from these measures will offset severe state budget cuts to our schools, protect the quality of education, enhance math, science, and technology education and offer classroom music programs K-12. Parcel Tax Citizen's Oversight Committees were established for both measures. The purpose of the committees is to inform the public concerning the expenditure of parcel tax revenues and to actively review and report on expenditures.

Plan

Measure H and Measure I transactions will be accounted for in separate funds to ensure that all transaction are transparent to the community and the committee. Therefore; two funds, 8205 for Measure H and 7502 for Measure I, need to be established at the county treasurers' office for accounting purposes.

That the board of education approve the establishment of fund 8205 for Measure H and fund 7502 for Measure I with the county treasurers' office.
