Subject: Acceptance of Completed Contract, Pavement Maintenance at Santa Barbara High School and Adams Elementary School

Consent Agenda: April 14, 2009

Background:

On June 24, 2008, the Board awarded a contract to Lash Construction, Inc. in the amount of \$172,498 for the subject project.

Issue:

Pursuant to Civil Code Section 3093, a Notice of Completion must be filed within 10 days after the completion of the work or improvement. The design architects, engineers, inspectors, and construction/project managers have inspected the project and are satisfied that all work has been completed per the contract documents.

To ensure the district has received all preliminary 20-day and stop notices per Civil Code Sections 3183 – 3184, retention will be held for not less than thirty-five (35) days. In accordance with Public Contract Code Section 7107, retention will be held not more than sixty (60) days.

Fiscal Impact & Funding Source:

The completed construction contract amount is \$191,994.36. This project was funded with elementary deferred maintenance (Fund 14, \$126,246.36) and secondary developer fees (Fund 25, \$65,748).

Recommendation:

It is recommended that the Board accept the completed contract and direct staff to file the Notice of Completion with the County Records Office.
