Background

Statutory changes to the Williams Settlement as stated in California Education Code 35186 (d) requires that a school district report summarized data on the nature and resolution of all Uniform Complaints on a quarterly basis to the county superintendent of schools and the governing board of the school district. Further, the summaries must be publicly reported on a quarterly basis at a regularly scheduled meeting of the governing board of the school district. The report must include the number of complaints by general subject area with the number of resolved and unresolved complaints. The complaints and written responses must be available as public records.

Education Code 35186 (a) states that a school district shall use the Uniform Complaint process it has adopted as required by Chapter 5.1 (commencing with Section 4600) of Title 5 of the California Code of Regulations, with modifications, as necessary, to help identify and resolve any deficiencies related to instructional materials, emergency or urgent facilities conditions that pose a threat to the health and safety of pupils or staff, teacher vacancy or misassignment, and complaints relating to CAHSEE Intensive Instruction and Services for pupils who have not passed one or both parts of the high school exit examination by the end of grade 12.

Findings

For the quarter ending March 2009, the Santa Barbara School Districts have received zero complaints. The Quarterly Reports on Williams Uniform Complaints Education Code 35186 are attached.

Recommendation

That the Board of Education accept the Quarterly Reports on Williams Uniform Complaints.
