Subject: Approval of Award of Contract Extension to Greenkeeper for Landscape Maintenance at La Colina Junior High School

June 9, 2009 Consent Agenda

Background:

The Agreement for Joint Use, Programming, Maintenance and Development with the City of Santa Barbara was approved by the City of Santa Barbara on January 31, 2006 and by the Board on February 14, 2006. This agreement allows the district to invoice the City up to \$35,500 per year in extra maintenance costs to keep the four jointly developed fields to an agreed upon Minimum Maintenance Standard. In an effort to meet that standard, the district contracts for the maintenance of the main field at La Colina Junior High School.

On June 4, 2003 the board awarded a contract to Greenkeeper for Landscape Maintenance at La Colina Junior High School. This contract allows for annual renewals of additional 12 month periods using the same terms and conditions. Greenkeeper requested, and the Board has approved, previous annual extensions.

Plan:

The district is pleased with the services of Greenkeeper and Greenkeeper has advised that they wish to renew the contract for an additional 12 months at the same terms as the original contract. Attached is Greenkeepers request for a contract extension.

Fiscal Impact and Funding Source:

\$23,800. Secondary general fund, grounds budget (fund 01)


Dear Mr. Hetyonk,
