Background

Education Code 44258.9 requires that annually a report be made to the Board of Education on verifying the legality of each teacher's assignment as an action item. The Commission on Teacher Credentialing allows districts to approve teachers to teach under a variety of Education Codes: 44256 (b), 44258.1, 44258.15(a), 44258.2, 44258.3, 44258.7(b) and 44263 which are outside their credential area, and thus they are considered appropriately credentialed.

RE: Report of Annual Teacher Assignments with Approval of Teachers to Teach Under Education Codes: 44256(b), 44258.1, 44258.15(a), 44258.2, 44258.7(b), 44263, and 44831 and Adoption of Resolutions 09/10-11 and 09/10-12

**Background**

Education Code 44258.9 requires that annually a report be made to the Board of Education on verifying the legality of each teacher’s assignment as an action item. The study of teaching assignments for the 2009-2010 school year and credential authorization has been completed. All teachers are authorized to teach their assignments.

Due to the complexity of staffing at the secondary level, the Education Code provides several provisions for teachers with expertise and experience in an area not listed on their credential, to teach in that area. Teachers approved under these codes are encouraged when possible to add the subject area to their credential.

Education Codes 44256(b), 44258.1, 44258.15(a), 44258.2, 44258.7(b), and 44263 provide for teachers with expertise and experience to teach in areas outside their credentialed area. All teachers teaching under these Education Code provisions need their assignments approved by the Board of Education and in addition, Education Code 44256(b) and 44263 need approval of a Board Resolution.

Listed below are the Education Codes and the teachers teaching under the provisions of the codes. All the teachers teaching under the Education Codes meet the criteria and have expertise and experience in the subject area that they are teaching. The authorizations are renewed annually.

**Education Code 44263:** This code authorizes the holder of any teaching credential, with his/her consent, to teach any departmentalized class in which he/she has 18 units or 9 upper division units in the subject being taught. Requires a Board Resolution.

**Education Code 44256(b):** This code authorizes the holder of an elementary credential to teach, with his/her consent, departmentalized classes in which he/she has 12 units or 6 upper division units in the subject. Requires a Board Resolution.

**Education Code 44258.1:** Authorizes elementary-type credential holder to teach in middle school – **REQUIRES** teaching 2 or more subjects for 2 or more periods per day to the same group of students and may teach any of those subjects to a separate group of students at the same grade level.

**Education Code 44258.2:** This code authorizes the holder of a secondary-type credential to be assigned to teach with his/her consent, classes in a middle school in which he/she has 12 units or 6 upper division units in the subject.
