Subject: Waiver of Unused School Site Fees

Conference Item (Time Required: 10 min.)

## Background

The Santa Barbara School Districts are currently assessed unused school site fees totaling approximately \$125,000 per year. The current charge to the Elementary District for the Hidden Valley Site is \$44,798, and the fee to the High School District for the Tatum site is \$79,000. Both these assessments will increase this year. The fees are imposed by the Office of Public School Construction for the State Allocation Board pursuant to the provisions of Education Code Section 17219 and implementing regulations

## Issue

Section 17219 provides that nonuse payments shall not be required for any year in which the school site is used for half of the year or more for any of the following purposes: "by the school district, or by any other governmental entity pursuant to agreement with the school district, for school purposes, for use as a Civic Center, or for community playground, playing field, or other outdoor recreational purposes."

Currently, the Tatum site is available and used by the public for various types of informal outdoor recreation uses, including walking, jogging, bicycling and outdoor nature. The Hidden Valley site, although presently fenced, offers similar recreational opportunities. Although we feel that it may be worthwhile to apply for a waiver for unused site fees based on this use, it may be in our best interest to take measures at the Hidden Valley school site, such as the installation of appropriate signage and trash receptacles, delineating ingress and egress from the site and reviewing the associated liability of such, before applying for a waiver of unused school site fees.

## Waiver of the Fee

Once an unused site is subject to the fee, there are provisions in the law to waive the fee for the following specific reasons and time periods:

- » The district submits documented evidence that the site will be used within a reasonable period of time for one of the exclusions as outlined in Section 2, Unused Site. A reasonable period of time is generally deemed to be no more than three years unless the SAB determines a longer period of time is justified. If a waiver of a site is approved by the SAB, the waiver will begin in the fiscal year the waiver is approved. For example, if the SAB approves a waiver in the 2004–05 Fiscal Year, no fee will be required for that fiscal year.
- » The district may qualify for a one-year waiver if a good faith effort has been made to sell the site at fair market value, but no acceptable bid value was received. The waiver of the fee will apply in the fiscal year the waiver is approved by the SAB.
- » A waiver of the fee is automatically granted when the adjusted value of the site is less than \$33,870 as of the 2004–05 Fiscal Year. This amount is adjusted for inflation each year based on information contained in EC Section 42238.1.
- » The district submits documented evidence that the site is being used for at least ½ of the fiscal year to a tenant who is paying possessory taxes for that fiscal year equal to or greater than one percent (1%) of the current estimated value of the site, and a one-year waiver will be granted.

## Reduction of the Fee

The fee may be reduced for a given fiscal year, if a district utilizes the site for at least one-half of that year for one of the following purposes:

This form is used for each site requiring attention and must be returned by July 1, of each year. Complete only those sections that are relevant to the district's needs. Refer to Education Code (EC) Sections 17219 and 17224.

**GENERAL INFORMATION**

The following are definitions and criteria used for unused sites.

**Type of Use (for Sections I, II and IV)**

1. The site is currently used for the specific purpose for which it was acquired. This is deemed to mean used as an active K-12 school. A site acquired for use at one grade level may be used at another grade level.
2. The site is currently used to house students for any California Department of Education program (including Adult Education) authorized by the Legislature, and operated by public school districts for which the district is receiving State School Fund apportionments.
3. The site is currently used to house special education students.
4. The site is currently used for district administration purposes including such support services as warehousing and maintenance facilities.
5. The site is currently used for preschool or child care centers when operated by or under contract with a public school district or a county superintendent of schools.
6. The site is currently used for a community college if attendance is allowed for high school students who have been recommended by the district, accepted by the college and are in the 11th and 12th grade (or in a lower grade and have received special approval). None of the class work may be used to supplant high school graduation required course work without special approval by both the district and the college.

**Waiver of Fee**

A district may have the unused site assessment fees waived for a site which is being utilized more than one-half the fiscal year for the following purposes:

1. The district or any governmental agency, pursuant to an agreement with the district uses the site for one of the following purposes:
  - for public school purposes as outline under Type of Use listed above.
  - as a civic center used for the purposes as outlined in the Education Code Section 38131.
  - as a community playground.
  - as a playing field.
  - for outdoor recreational purposes.
2. The State Allocation Board, pursuant to agreement with the district utilizes the site to store emergency portable classrooms.
3. The district, or any public or private agency pursuant to agreement with the district utilizes the site for operation of a child care program.
