This is the first meeting of the Special Education Stakeholder Workgroup, an advisory group formed at the direction of the Board of Education. On August 11, 2009, the Board of Education approved convening a representative, self-selected stakeholders group “to review the categories of recommendations [contained in the Fiscal Crisis Management Team (FCMAT) special education report], consolidate any duplicates, identify responsible entities for implementation, and establish a suggested priority timeline”. A roster of Stakeholder Workgroup participants is attached to this agenda.

After the introductory and general matters listed on the below agenda, the Stakeholder Workgroup will be asked to divide into five ad hoc subgroups to concurrently study separate issues before reporting their recommendations back to the Stakeholder Workgroup as a whole. The Stakeholder Workgroup will then be asked to review categories, consolidate, and prioritize FCMAT recommendations.

In order to be compliant with the requirements of the Brown Act, the meeting of the Stakeholder Workgroup will be recessed during the separate meetings of the individual subgroups, and then will be reconvened to complete the remainder of the agenda. Due to legal requirements Stakeholder Workgroup members may not move from one subgroup to another.
